### **Evaluation Classes to choose from:**

**Class Nr. 1** Full Evaluation (conformation- rideability) \$ 290.- ( 25 spaces available)  
Horses have to be at least 4 years old (born 2004, or earlier)

**Class Nr. 2** conformation only \$ 210.-

**Class Nr. 3** Foals and young horses up to 4 years. (Judged on halter and at liberty)  
The results may be entered at a later time into the WF data base. \$ 85.00

**I understand that the horse has to be micro chipped, vaccinated and healthy.**

Horses have to be micro chipped before entering into the show. The Veterinarian on call will not perform this service.

Regarding the vaccination proof is required and it has to be minimum 4- way. (incl. influenza)

Space is limited. THE HORSE IS ENTERED INTO THE EVALUATION AS THE PAYMENT IS RECEIVED. On arrival the waiver has to be signed to participate in the event.

**Stallion owners**, please ask for the regulations on the required Spavin test.
